Policy on School Uniform

1 Introduction

1.1 It is our policy that all children should wear school uniform when attending school, or when participating in a school-organised event outside normal school hours. We provide a complete list of the items needed for school uniform on the school website or in the school office.

2 Aims and objectives

- 2.1 Our policy is based on the notion that a school uniform:
 - promotes a sense of pride in the school;
 - engenders a feeling of community and belonging;
 - is practical and smart;
 - identifies the children with the school;
 - is not distracting in class (as fashion clothes might be);
 - makes children feel equal to their peers in terms of appearance;
 - is regarded as suitable, and good value for money, by most parents and carers;
 - has been designed with health and safety in mind.

3 Make-up / Nails

Children are not allowed to wear make-up of any kind and nail art is forbidden.

4 Jewellery

4.1 On health and safety grounds, we do not allow children to wear jewellery in our school. The exceptions to this rule are ear-ring studs in pierced ears, and small objects of religious significance, such as a crucifix on a chain. We ask the children either to remove these objects during PE and games, or to cover them with a plaster.

5 Extreme haircuts

5.1 The school does not permit children to have haircuts that could serve as a distraction to other children.

6 Footwear

6.1 The school wants all children to grow into healthy adults. We believe that it is dangerous for children to wear shoes with platform soles or high heels in school, so we do not allow this. Neither do we allow children to wear trainers to school; these are appropriate for sport or as leisurewear, but are not in keeping with the smart appearance of a school uniform. We require all children to wear sensible black flat shoes or boots (winter).

7 The role of parents and carers

- 7.1 We ask all parents and carers who send their children to our school to support the school uniform policy. We believe that parents and carers have a duty to send their children to school correctly dressed and ready for their daily schoolwork. Parents and carers should ensure that their child has the correct uniform, and that it is clean and in good repair.
- 7.2 The school welcomes children from all backgrounds and faith communities. If there are serious reasons, e.g. religious objections, why parents and carers want their child to wear clothes that differ from the school uniform, the school will look sympathetically at such requests. Similarly, should an item of school uniform prove problematic for a pupil with disabilities, then parents and carers are invited to draw this to the attention of the headteacher. The school will not treat pupils with disabilities unfavourably.

8 The role of governors

- 8.1 The governing body supports the headteacher in implementing the school uniform policy. It considers all representations from parents and carers regarding this policy, and liaises with the headteacher to ensure that the policy is implemented fairly and with sensitivity.
- 8.2 It is the governors' responsibility to ensure that the school uniform meets all national regulations concerning equal opportunities, and that our school uniform policy is consistent with our policy on equal opportunities.
- 8.3 Governors ensure that the school uniform policy helps children to dress sensibly, in clothing that is hardwearing, safe and practical.

9 Monitoring and review

- 9.1 When monitoring this policy, through its committee work, the governing body will:
 - seek the views of parents and carers, to be sure that they agree with the policy, and support it;
 - consider with the headteacher any requests from parents or carers for individual children to have special dispensations;
 - require the headteacher to report to the governors on the way in which the policy is being implemented.
- 9.2 This policy will be reviewed by the governing body as and when required.

Main Uniform:

School V neck jumper - Navy blue with logo

Cardigan - Navy with logo

Polo Shirt - White or navy with or without logo

Dark trousers/shorts- black/navy/dark grey

Skirt (tartan)

Summer dresses – blue and white gingham. (with or without logo)

Pinafore dresses – navy/grey (with or without logo)

Footwear – Black robust shoes. NO TRAINING SHOES

Socks/tights - black/grey/white

Year 6 uniform:

Initial uniform will be provided by the school free of charge for Year 6 pupils only.

This includes:

- 1 x Grey "V" neck jumper with blue trim
- 1 x white shirt
- 1 x blue tie

Same rules apply in regard to footwear and trousers/skirts.

PE Kit:

Blue/Black shorts

White T Shirt (with or without logo)

Footwear – plimsoles or training shoes for indoor PE. Training shoes must be worn for outdoor PE lessons.

Tracksuit or jogging bottoms for the winter.

Coats:

Suitable coat appropriate to the season.

Fleece jackets

Reversible jackets - showerproof

Beanie hats

Safari hats/sun cap
